In pursuance of the recommendations of the J&K Service Selection Board conveyed vide communication No. JKSSB/Scry/12/2025-06(E-7729719) dated 02.03.2026 to the Health and Medical Education Department and forwarded to this office by the Health and Medical Education Department, vide thier communication No. HD-Drgs/88/2026-02(7748270) dated 28.04.2026 and on the basis of Character and Antecedents verification report received from the J&K Criminal Investigation Department, sanction is hereby accorded to the appointment of **Ishfaq Majeed Makroo S/o Abdul Majeed Makroo R/o Rakhi Momandanjipora Bijbehara Anantnag 192124** as Laboratory Technician in the Pay Level-6 (35400-112400) in the Divisional Cadre Jammu of this Organization.

The appointee shall report in the office of Drug Analyst, Combined Food and Drug Laboratory, Jammu alongwith following documents, in original:-

- a. Date of Birth Certificate.
- b. Qualifiaction Certificates
- c. Domicile Certificate
- d. Medical fitness certificate from CMO concerned.
- e. Certificate to the effect that if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industies Center(DIC) and District Employment and Counselling Center of the domicile District, he shall relinquish the proprietorship of unit/eterprises and also stakes, if any, in such self employment Unit/enterprises before joining the Governemnt Service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes , if any. In such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- f. Relevant Category certificate, where-ever applicable.
- g. Any other documents as required under rules.

The appointment of the candidate shall be subject to the following conditions:-

1. The appointee shall join within a period of 21 (twenty one) days from the date of issuance of the appointment order. In case the appointee fail to join within a period of twenty one days from the date of issuance of appointment order, he shall forgo his right to appointment which shall be deemed to have been cancelled abinitio without any further notice.

2. The appointee shall be on probation for a period of 2 (two) years.
3. Verification/ Genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities shall be conducted / ascertained. The appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification his qualification / date of birth / reserved category certificate from the concerned issuing authorities is found fake/forged, his appointment as Laboratory Technician in the Pay Level-6(35400-112400) in the Divisional Cadre Jammu of this Organization shall be deemed to have been cancelled abinitio and legal action as warranted under rules shall be initiated.
4. The salary of the appointee shall not be drawn and disbursed to him unless, satisfactory report with regard to genuineness of his qualification certificates , date of birth certificate, reserved category certificate etc from the concerned authorities is received in his favour.
5. The appointee shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
6. The interium arrangement, if any made against the above posts shall be deemed to have been terminated forthwith.
7. The appointment in Divisional Cadre is non transferable from one Division to another.
8. The appointment of the selected candidate shall further be subject to the outcome of writ petititon(s), if any, pending on the subject in any court of competent jurisdiction.
9. The inter-seniority of the above appointee shall be determined in accordance with the provisions of the Jammu and Kahsmir Civil Services (Classification, Control and Appeal) Rules, 1956.
10. The appointment of the above named appointee shall be governed by other applicable rules and regulations.
