In pursuance of the recommendations of the J&K Services Selection Board conveyed vide communication No. JKSSB-Scry/12/2025-06(E-7729719) dated 26.05.2026 to the Health and Medical Education Department and forwarded to this office by the Health and Medical Education Department, vide their communication No. HD-Drgs/88/2026-02(7748270) dated 16.06.2026 and on the basis of Character and Antecedents verification report received from the J&K Criminal Investigation Department, sanction is hereby accorded to the appointment of following selected candidates as **Food Safety Officer in the Pay Level-6F(40800-129200)** in the Divisional Cadre Jammu of this Organization:-

The appointees shall report in the office of Deputy Commissioner Food Safety, Jammu along with following documents, in original: -

- Date of Birth Certificate.
- Qualification Certificates
- Domicile Certificate
- Medical fitness certificate from CMO concerned.
- Certificate to the effect that if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Center (DIC) and District Employment and Counselling Center of the domicile District, he/she shall relinquish the proprietorship of unit/enterprises and also stakes, if any, in such self-employment Unit/enterprises before joining the Government Service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDOs concerned from his/her salary. DDOs concerned shall obtain an affidavit from the concerned appointees regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- Relevant Category certificate, where-ever applicable.
- Any other documents as required under rules.

The appointment of the candidate shall be subject to the following conditions: -

- The appointees shall join within a period of 21 (twenty-one) days from the date of issuance of the appointment order. In case the appointees fail to join within a period of twenty-one days from the date of issuance of appointment order, he/she shall forgo his/her right to appointment which shall be

2. The appointees shall be on probation for a period of 2 (two) years.
3. Verification/ Genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities shall be conducted / ascertained. The appointees shall give an undertaking in the shape of an affidavit to the effect that if on verification his/her qualification / date of birth / reserved category certificate from the concerned issuing authorities is found fake/forged his/her appointment as Food Safety Officers in the Pay Level-6F(40800-129200) in the Divisional Cadre Jammu of this Organization shall be deemed to have been cancelled abinitio and legal action as warranted under rules shall be initiated.
4. The salary of the appointees shall not be drawn and disbursed to him/her unless, satisfactory report with regard to genuineness of his/her qualification certificates, date of birth certificate, reserved category certificate etc from the concerned authorities is received in his/her favour.
5. The appointees shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
6. The interim arrangement(s), if any made against the above posts shall be deemed to have been terminated forthwith.
7. The appointments in Divisional Cadre are non-transferable from one Division to another.
8. The appointments of the selected candidates shall further be subject to the outcome of writ petition(s), if any, pending on the subject in any court of competent jurisdiction.
9. The inter-seniority of the above appointees shall be determined in accordance with the provisions of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956.
10. The appointments of the above-named appointees shall be governed by other applicable rules and regulations.
